Development Funding for Fernwood donated by Barrett/David Wilson Homes

One group made a successful bid for the Fernwood Development Project:-

Fernwood Over Fifty Fives made a bid of £2020 for a Defibrillator package which consists of a Defibrillator and Cabinet to be fitted next to the door of the village hall.

This means there is £3201 left in the account.

New bids to be submitted before the end of August

The project group agreed that further bids would be accepted at the end of August for the remaining money. Therefore, if you or your group can think of a suitable project that would benefit your group and the village, please submit your application as soon as possible. The Project Review Group will review the merits of any project submitted and prioritise those for immediate consideration.

In order to make the application process as straightforward as possible an attempt has been made to simplify any rules/conditions governing an award. However, they will include:

- (a) The applicant shall give brief details of what the project is and how it will benefit the group and the development of the village and residents.*
- (b) a condition that any project is completed within one year*
- (c) the validity of any application must be supported a bank account and/or Minutes from the group or supporting user group – thereby giving confidence that there is sufficient backing to both control the expenditure and delivery of any project*
- (d) If a project fails or comes in under budget all excess money will be returned.*

Initial enquiries should be directed to the Chairman of the Project Review Group, John Proctor – final submissions by the end of August.

Life moves on in Fernwood. On 15th April the Chairman of Newark & Sherwood District Council, Dennis Jones, presented a Big Lottery Fund Cheque for £9226 to the FRA. He declared the new equipment of teenage shelter and trim trail exercise machines officially open. County Councillor Sue Saddington, District Councillor Ivor Walker, Parish Council Chairman Jim Weale and representatives from OM and Barrett/David Wilson Homes and the Parish Council were in attendance. The FRA extends their thanks to members of the Petanque Club and Over 55 Club for a wonderful spread and their hospitality.

Since then the Residents' Association have held an open meeting and AGM. Guest speakers included Mr Bob Hattersley, Head Teacher of Chuter Ede Primary School and Robert Galij, Planning Director Barrett/David Wilson Homes.

Mr Bob Hattersley talked about the progress of the building of the new Fernwood Chuter Ede

annexe which is now expected to be completed in time for the new academic year. Our next Residents' Open Meeting on September 9th will be held in the finished school. Residents should arrive at 7.00pm so they can look around the new building before the meeting starts 7.30pm.

Mr Hattersley answered questions at our June Meeting with regard to pupils' application to Chuter Ede and its Fernwood annexe. He explained the procedures for acceptance and the problems experienced because of over subscribing due to the popularity of the school. The school and its governors are doing their best to overcome the problems particularly felt by Fernwood with more Fernwood children than places available on the Fernwood site.

Mr Robert Galij of Barrett/David Wilson Homes, through a series of display boards talked about the proposed development of Greater Fernwood. He opened his remarks with reference to the school

which initially had been designed to meet the needs of the original village (now referred to as Fernwood Central). The needs of the new-build (Fernwood North) will be met by a further extension of Fernwood Chuter Ede annexe. Mr Galij said he would clarify with the sales staff about the admissions policy for the school and how it would affect people moving into new property in Fernwood. He repeated that it is hoped construction traffic for the new North Build will not come through the village (ie Fernwood Central). The proposal so far is to use Hollowdyke Lane and Spring Lane with appropriate road improvements. There was concern expressed about the closing of vehicular access from Spring Lane under the A1 as this could isolate the village in the event of a closure of the bridge over the A1. There is concern also about the pressure on the existing facilities in Fernwood Central which is already under pressure from the existing village. Mr Galij answered the worry about flood-risk by assuring the audience that all flood-risk

assessments had been undertaken by Severn Trent and Anglia Water authorities.

The meeting finished with all residents being encouraged to express in writing any concerns about the proposals to the Parish Council and/or the FRA or your District and County Councillors. Barrett/David Wilson Homes would then consider any such comments in submitting their Planning Application. Concerns in writing can be brought up and discussed by representatives of the Parish Council and the FRA at Fernwood Development Meetings attended by Barrett/David Wilson Homes, OM, Highways, and Representatives from Newark & Sherwood District Council including planning, Nottinghamshire Education Authority including the school, and representatives from Nottinghamshire County Council.

A strategy for Fernwood—Cllr Jim Gould

What is evident is that there are issues which cannot be handled by the Parish Council. This is a small team of well meaning individuals who, admittedly, do not have the wide ranging skills or the number of hours required to effect solutions for the betterment of Fernwood and its residents. Accordingly, it has organised a Strategy Group which will monitor and progress the following:

OM (the maintenance team): their service level performance and related charges.

The proposed North development (by David Wilson Homes/Barratts), encompassing the build of another 950 homes.

A formal Parish and Neighbourhood Plan – involving future build programmes, the Council's service to residents, parking, speeding and how the local precept should be expended.

The recommendations resulting from the deliberations of the group will be formalised through a reporting structure via the Parish Council which, in its

turn, will be presented to what is commonly referred to as the Development Meeting, which involves all stakeholders to the village. Usually these gatherings are held every six months or so and to date have proved ineffective – it would not be unfair to say that, for the main part, Fernwood has been paid *lip-service* as far as our demands are concerned.

Plainly, this situation needs to change and through a larger working party, and with our acknowledged contacts in the Press and Media, we are optimistic

that some overdue attention and action should be afforded to our village. Fernwood is frequently lauded as an ideal for the future – a model for the proposed Growth Point strategy involving the build of another 20,000+ homes in the Newark area. However, what chance for future growth prospects if it has not completely worked in our village? Fortunately, through the excellent community spirit generated by our Residents' Association, User Groups, Parish Council and the effective management of the Village Hall we now have a nucleus of dedicated

The three months since the last fanfare seem to have gone by in the blink of an eye. Sadly we are still roughly in the same position as before, still waiting to see how the plans for the New Development will proceed, but it seems that from all our efforts things possibly have slowed down a little bit, giving us more time to re-group.

I have been in touch with the Environment Agency and they are very aware of possible flooding problems and that due to "Global Warming" the situation is different from five years ago

when the Growth Point was first approved. The many floods throughout the country have given them food for thought.

There is, according to my source, a big environmental meeting at Kelham to be held on 4th July so we shall await the outcome of that with interest.

Another problem which we are fighting at the moment is the destruction of ancient hedgerow in Hollowdyke and Spring Lanes which involves access and exit to the new build at Fernwood North.

Despite many requests Fernwood is still not on the A1 signs, which I am told is a matter of costs, although I read in the Advertiser that DWH/Barratt are contributing to the widening of the junction of London Road with Bowbridge Road in order to take care of extra traffic from the new development. A question of priorities!

Parking in the village is still an ongoing problem which cannot be addressed until the roads are adopted. It seems that more and more residents are taking notice and are willing to do

something about it. Both the Parish Council and Residents' Association appreciate any help you can give.

Don't forget the Fernwood "Picnic in the Park" on Saturday 19th July from 2.00 till 6.00 pm. There will be plenty of food and a bar so come along and relax, hopefully in the sun.

knowledgeable and experienced residents who are able to address the many day-to-day issues that face us. Already, some 40+ individuals have indicated an interest in contributing to the work of the new Strategy Group.

At its inaugural meeting, 16 residents attended who will be instrumental to the process of collating and deciding on the formation and progression of a future strategy for Fernwood. Their findings will be cemented through a structure which will have due formal recognition and *buy in* from all parties especially our District and County Councils.

Immediately, it was recognised that we have some obstacles to overcome to protect Fernwood's future:

*Our ownership of the land – we need to secure this in agreement with the developers.
The reported re-mortgaging*

and house sales delays because of the interest by the maintenance company (OM) – their level of service maintenance and management charges which need to be made transparent.

An input to the wider build programme – not just the immediate build programme of 950 homes, but another 2000 or so that are planned for the South of our village.

The need for a visionary statement and delivery programme for our Parish Council on behalf of residents to deal with the facilities and services our developing village will need, despite external resistances.

A sensible road access and public transportation system – unbelievably this is considered satisfactory by the authorities.

Increased car parking facilities – and with due road adoption to curb speeding and illegal parking practices

Value for money in respect of the council taxes levied.

Improved communications to ensure better engagement with residents via bulletins, email contacts, web 'blogs' etc. etc.

There has, so far, been a prevailing feeling that there is not much we can do about "the system", that no matter what we do or say we can alter nothing - "*it's going to happen so why resist – and if I'm OK and just too busy why be bothered?*" However, what many residents are now realising is that the latest developments will definitely have an impact on their lives – surprised that current changes to the build programme have altered access to their properties, parking and general outlook.

We can have a say in all of this and already the developers are starting to look at the contractual arrangements with the maintenance team,

the Planning Department's discussions on the outline North build development have been deferred and certainly the latest communications by residents and by your Parish Council would have had an impact in this respect.

Let's ensure that Fernwood is a great place to live and raise our families.

So, if you are interested in taking part in the ongoing strategic review or just being updated please do not hesitate to contact your Parish Council.

Understanding your OM Maintenance Charge by Sue Taylor

Some of you may know

that I have been asking OM for many years now to explain how our maintenance charge is calculated for each individual. You would think that this would be easy for them as they are the ones who create the bills but I have found that clarity and accuracy together with communication are not their strong points. I have been concentrating on the Schedule 1 charge only as this affects ALL dwellings in Fernwood who pay the charge. Recently I managed to get some information which may make the final accounts clearer to everyone and enable you to check your bills for accuracy. I am still waiting for OM to confirm my understanding.

Even though your transfer document states that you should pay your percentage of Schedule 1 total, this is

not the case. The Management Fee is treated as a separate entity. Why this is not made clearer in the accounts is anybody's guess but it does hide the fact that we are being charged a considerable amount more for management than the actual cost to maintain the public open spaces.

The Management Fee is termed as a '*fixed fee*' per dwelling and is decided at the beginning of each accounting year with VAT added. As we are charged proportionately to the size of our dwellings, this '*fixed fee*' is then multiplied by the number of dwellings in a completed site; 969 for the years up to 31st May 2013.

The portion of Management Fee allocated to you (A) is your % x the total management fixed fee.

The Management Fee shown in the final accounts relates

only to those dwellings which were occupied, so take the actual management fee quoted from the net Schedule 1 total to find out the actual cost of maintenance and multiply this figure by your %. This will be your contribution to the maintenance (B).

Add the two parts (A+B) and that is how much you should be paying for that accounting year.

Note: If you have not been resident for a full year (1st June - 31st May), you should divide A+B by 365 and then multiply by the number of days since purchase.

I have received my account breakdown for a few different years and I have to say that I believe I have overpaid every year since 2006 mainly due to OM using incorrect figures to calculate the Reserves or Insurance or Gardening Costs

but I am yet to get OM to agree this and my last communication with Mr Robert Howell was in February of this year. 4 months later and he is still unable to reply to my questions and comments.

Bearing in mind that we should all be charged in the same manner, I would hazard a guess that everyone who pays/has ever paid the maintenance charge has been overcharged. Not by much each year but it is the principle that matters, especially as the portion allocated as management fee is so ridiculously high. There is no explanation to what this fee covers and we do not get a good service.

Up to 2013 I am to pay 0.111% of schedule 1 and if I was charged correctly the following breakdown shows the expenses and management fee separated out for each year.

You may also like to know that I have questioned the expenses for 2012/13

Did you know?:

- that we have been charged the solicitor fees which enabled the change to our percentages because the developer decided not to build as many houses as first thought?
- that the 'Reserves' pot has been emptied without consultation with the residents? What happens now if there is emergency maintenance required?
- that OM do not arrange the grass cutting etc.? This is done by the developer

and charged to OM. For 2012/13 this was only £32,050.27. *OM are yet to explain about the other £14,000 expense charged.*

- that repairs to the playground fence and surrounding ground were made which constituted most of the £2,280 expense? *OM are yet to provide the invoice.*
- that we paid £2,400 for a soak away somewhere? *OM are yet to explain where.*
- that it cost £750 to sort out a branch that had fallen off a tree? *I have only been shown 2 invoices total £1,600 out of the*

£7,386 expense for 'Additional Tree Work'

- that it cost £2,200 to knock a dividing wall down in the bat house to provide more storage and to build a fence (150mts) on the south of the football pitch?

Last October I asked the Residents' Association to invite OM (or anyone else who maintains the land) to explain the expenditure on a yearly basis and discuss the future year plan for maintenance. For reasons I am not aware of this was rejected by the committee in November but a promise to discuss again after the

investigation report had been issued. It was a long wait and not as thorough as I had been led to believe but that report was issued in February. Hopefully now the Residents' Association will think again.

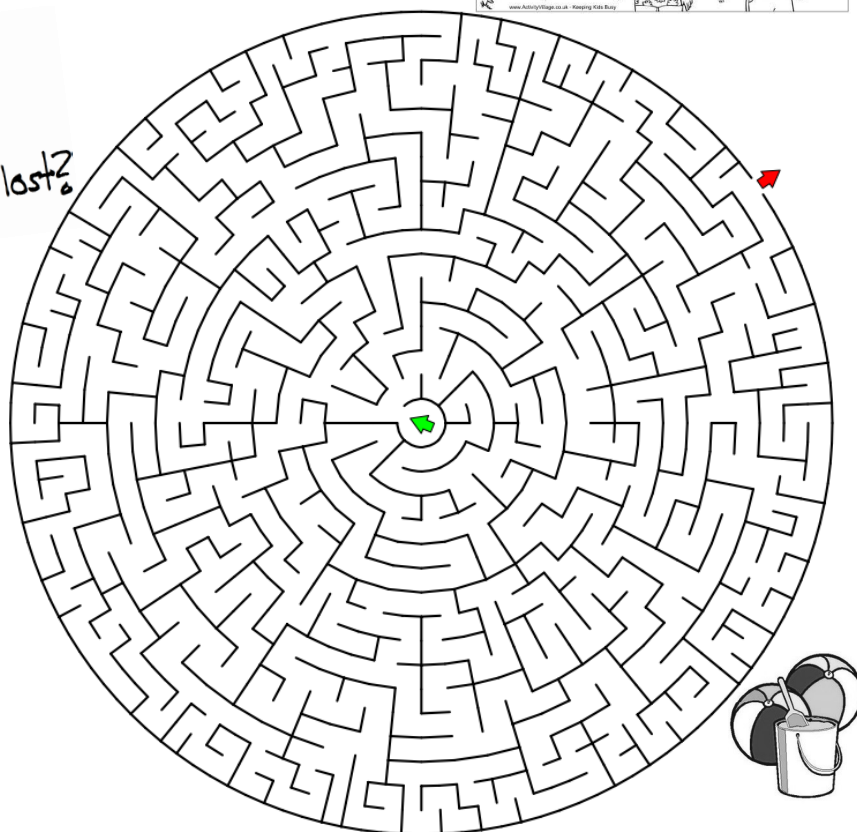
