Hello Marion,

Please see two quotes attached – I have tried to find another company I'd be happy to ask to quote, but to no avail. Both are <£5,000, so I trust this should not be an issue.

It is up to you which to use – Tracsis quoted previously and are slightly cheaper, while PCC TIC are our usual supplier with whom we have an excellent relationship.

I need to revise my previous quote. Part 1 of my previous allowed for Survey set-up, etc, but no meetings at £595 – we have now done this work pus a meeting for £800 (£400 invoiced, further Invoice to follow). So that is essentially resolved.

My Part 2 allowed for preparation of a Transport Statement [TS] at time charge rates up to £2,000. I anticipate a similar fee for the TS, but would ask that the time charge allowance be increased to £2,500 to allow for our detailing the expanded survey brief, and the small amount of design work required in relation to the disabled bays, pedestrian access route, etc. Assuming this is acceptable in principle to your members, I can get you revised paperwork in due course.

I am away on site tomorrow, but may be reached on my mobile around lunchtime, say between 12 and 2pm.

Good morning, Andrew.

Thank you for your message and detailed scope for the work required. I note that you have tentatively marked up on the plan the likely camera positions which upon first glance look sensible to me however when looking at the street view images, I'm not so sure. Having discussed the survey in the office the consensus here is that we would prefer to place cameras at the locations shown on the attached image. That all said I would ultimately have to defer to the installation team regarding the equipment locations as the ground-based viewpoint may differ from what can be seen on Google maps but with an understanding that we agree before hand where the no go locations are.

A few things to consider.

- Ruby's Avenue appears to be an adopted road and assuming I am correct will fall under Nottinghamshire's care. That will mean a license permit is required to place CCTV on site. The license costs £75 plus VAT assuming you are happy to share the data with the LA, or £125 plus VAT if you prefer not to share the results. The license permit will take 2 weeks to procure so just be mindful if trying to hit specific survey dates of that lead in time. Please choose the permit fee which best suits you and note that the permit fee <u>must be added</u> to the survey proposal costs above.
- Whilst we currently have capacity to survey the preferred dates our own schedule moves
  constantly and is subject to change. Due to the approaching May day and Coronation bank
  holidays, we are aware of increased activity to book surveys immediately after those days
  and together with the Whitsun half term at the end of May we have a very short month
  available to survey.
- Whilst a permit from the LA allows us to survey from the public highway there may be other constraints regarding the use of CCTV at site, you mentioned the yellow area is privately owned however our preference would be to mount a camera on the lamp column directly outside the village hall looking across the car park towards the direction of the road running past the nursery. That isn't within the car park boundary so it shouldn't be an issue? Please also note that the CCTV locations will have multiple units to cover off any redundancy or failures, I'm also thinking that if any of them are tampered with we have a provision to cover that all be it unlikely eventuality.
- You should also consider that CCTV deployed in any public space can come under scrutiny
  and prior to setting up the equipment the businesses that operate from the designated
  survey areas are informed that the survey will be taking place for full transparency. I should
  just mention that the CCTV we use do not have any facial recognition or capacity to read
  number plates, as these units are deemed as low definition,

On that basis of the above I can confirm our fees to complete a continuous parking accumulation survey for your preferred survey dates and for the suggested hours is £4770 plus VAT to follow the methodology you have written.

We will present the parking results based upon the coloured zones as shown in your plan after 7 working days and will be in Excel format.

I trust that the above is helpful and would add that should you wish to speak to me regarding the project I am available in the office all day today.
