## Dear Emma

On behalf of Fernwood Petanque Club can we ask for written permission from the land owners to put a paved surround around the perimeter of the petanque terrain.

The surround will be 1.2 metres wide and will also connect the terrain to the 3 benches, This will allow disabled access to all parts of the terrain and will be wide enough for wheelchair and scooter access.

We would also like permission to put handrails around the paving to allow disabled and/or elderly to walk safely. The rails would match the rails surrounding the green in design and colour but will be plastic in construction so as to be safe to touch (no splinters!). The rail would be 3 ft high to enable its use as a handrail.

As you will appreciate some of our members are elderly and we have several disabled members. The terrain is open $24 / 7$ so it will enable safe access for visitors and other elderly or disabled residents who wish to access the terrain, both as spectators or participants also the proposal will improve the area which floods during the bad weather.

The construction would be funded by the Petanque Club via self funding and on going maintainance would be funded by the Petanque Club

## Project :Plant the Banking a the beginning of Goldstraw Lane

Objective -To give Fernwood some character and a welcome ,cared for feel when entering the village.We would like to write "FERNWOOD" in flowers along the banking by cutting out the turf and infilling with flowers . Initially we would cut out the turf and infill with a light coloured chippings. This will maintain the outline and look throughout the year even in winter. Flowers can then be planted at appropriate times.

The Work To be carried out by the Conservation group ,Chippings and flowers to be funded by the group.

Ongoing Maintenance First Port currently maintain the banking by regular mowing and this will not change .However there will be a need for an occasional tidying of the edges .First Port have Kindly supplied us with a costing for this (see separate sheet) which works out to an annual cost of 8 pence per household .

It can be seen from the picture above that the path is well used, has not Jeen abused and is still tidy .In fact it turns out that it has required no maintenance so 'ar ,regular footfall keeping the path from becoming overgrown.

## ETTER-TO THE CLERK TO FERNWOOD PARISH COUNCIL

Dear Emma
The new procedures for approving changes to the public spaces maintained by First Port has not yet been fully proposed by FMSG and agreed by the Parish Council.

At the recent FRA Committee meeting, the latest projects submitted were reviewed and until proper approval procedures are in place FRA would like to provide the Councillors with their comments and recommendations. Please see below:

## Petanque Club

Following discussions a vote was taken on the two parts to the project:
A - 1.2 m wide paving surround to provide disabled access to all parts Vote - 7 For / 0 Against Recommended for Approval
B-3' green plastic handrails for disabled/elderly aid Vote 0 For / 7 Against
The Committee felt that more information is required for this part of the project. Not only the issue as to whether it was the right height for the elderly but the practicality of access and movement of mobility scooters and wheelchairs if the rail fenced in the area as detailed in the drawing. The issue of 3rd party liability also needs to be addressed in case of accidents due to the rail visibility/height etc. However, in principal if the handrail design and positioning could be shown as fit for purpose, the majority (vote 5/2) of the current committee would recomynend this part of the project.

## Points to address:

- 3rd party liability responsibilities

Noue. -

- Points of access from outside/inside
- How will it help?
- Height, colour and type (photographic example)
- Why the full surround like a fence?


## Conservation Group

One committee member has an interest in these proposals and therefore abstained from voting.
Project 1: FERNWOOD in Flowers
Concerns revolved around the upkeep of the cut FERNWOOD area especially if the group dissolved.

The Committee, however, felt that the creation of a simple flower bed would enhance the area and soass cutting in the rest of the area would be simplified with the edging of a single flower bed easier to maintain and would alsoleljminate any extra maintenance costs. The Committee suggested that the Conservation group could 'write the word FERNWOOD in flowers.

Vote 4 For $/ 2$ Agajet Recommended for Approval

Project 2: Woodland Walk
The group would create a new Woodland Walk behind Cameron Lane to discourage vandalism in the area. The group would absorb all costs through volunteers and there will be no on-going maintenance costs chargeable to residents.

Vote-6 For / 0 Against
Recommended for Approval
